Brief description:	This project, within the thematic priority 2 (AGRIP-SIMPLE-2023-IM-ORGANIC) of the "call for proposal" 2023 for simple programmes in the internal market, responds to the theme: - "Information and promotion programmes aimed at increasing awareness and recognition of the Union quality scheme for organic production methods as defined in Article 5 paragraph 4(b) of Regulation (EU) No 1144/2014" also made explicit in the Work Programme for 2023 of the Commission and the financial decision for the implementation of information and promotion measures concerning agricultural products carried out on the internal market and in third countries (Implementing Decision C(2022)- 9498 of 16.12.2022).
General objectives of the program:	The objectives of these programmes are in line with the general and specific objectives set out in Articles 2 and 3 of Regulation (EU) No 1144/2014. In particular: a) to improve knowledge of the merits of Union agricultural products and of the high standards applicable to production methods in the Union; b) to enhance the competitiveness and consumption of Union agricultural products and certain foodstuffs and optimise their image both within and outside the Union c) to strengthen awareness and recognition of Union quality schemes; d) increasing the market share of Union agricultural products and certain foodstuffs, with a particular focus on third country markets with the highest growth potential. The information and promotion actions are intended to - improve the level of knowledge of organic fruit and vegetables produced in the Union and of the high standards applied to European production methods; - Optimise the image of European organic fruit and vegetables to increase their competitiveness and consumption in the target countries; - Strengthen awareness and recognition of the Union's quality schemes, inviting people to perceive the differences and guarantees offered by organically produced products; - Highlight the specificities of the Union's organic fruit and vegetable production methods in terms of food safety, traceability, authenticity, labelling, nutritional and health aspects, respect for environment and sustainability, highlighting the characteristics of these products in terms of quality, taste, organoleptic diversity and traditions. organoleptic diversity and traditions. - Create consensus towards promotional messages and generate support, visibility and off and on-line coverage to planned initiatives and events.
